## **CBA Marching Committee Meeting 7/21/2022**

- Meeting Called to order 11:38am
- Roll call: Members present: Rick Shaw, WL Whaley, Bryce Malaragno, Sean Heading, Tim Libby, Phil Olivas, Ryan Crabtree, Karen Gregg, Aaron Herman, Craig Ketels,
- Financial report
  - o \$51,546.79
  - The majority of expenses are taken care of. Reservations and contracts are buttoned up for the season
  - \$35,000 of \$36,046 will be moved to CD to establish the \$105,000 CD
  - 3.5% increase in the budget due to inflation, but income is stagnant due to unchanged entry fees, ticket prices, etc.
  - Ticket price increase? 4A/5A probably ok. 1A-3A might need a bump.
    Investigating digital presale of tickets.
  - o A figure of \$12,494 has been requested as a transfer to balance the budget
  - This amount can range from \$0-30K
  - Discussion regarding transferring \$12,494 to balance CBA general budget
    - Philosophical ideas of balancing CBA budget
    - Motion by WL
    - 2nd by Tim Libby
    - Motion passes to transfer \$12,500 to CBA general account
- Membership
  - Sean Heading, invitation for Jeff Mason, Dylan Ford stepping down
  - 4 year term
- Badge Allocation
  - %10 discussion

- o 0-50 kids %12 compromise
- o 51> kids %10
- 1 pass for each certified directors (head director/assistants) and 1 guest pass for each participating school, 0-50 kids %12, >51 %10
- Maximum of 10 passes total per school in addition to the director(s) and 1 guests pass
- Motion by Tim Libby to accept proposal
  - 2nd by Phil Olivas
- Motion passes unanimously

## 4A/5A

- Heritage and Prairie View, same number of students in those schools. Both were put in 5A due to procedure of more in 5A than 4A. Ponderosa is not going to state, so that opens a spot. This would allow moving both schools back to 4A but would have a total of 25 in 4A, 24 in 5A. Committee deems it acceptable for chairperson to move bands to the class that balances the 2 classes.
- Motion from Craig Kettles to streamline cg exit of the field to match the winds/percussion to not cross the front sideline. Exit the endzone.
